


Custom Fitting Instructions:

DO NOT USE this mouth guard IF you have an under-bite (Class III prognathic jaw relationship).

FITS OVER BRACES: Immediately After boiling, channel flanges may be widened with thumb. After creating impressions, DO NOT push outside flanges inward against braces/teeth.





Sanitize regularly with an astringent mouthwash for good hygiene. With proper care, your guard should last for a whole season. 1.
